FEEDING DIRECTIONS

Feed at the rate of 2 lbs. per 100lbs. of body weight per day to provide 22.7 mg of Decoquinatate per 100 pounds of body weight (0.5mg/kg) per day. Feed at least 28 days during period of exposure to coccidiosis or when it is likely to be a hazard.

USE DIRECTIONS FOR ACTIVE INGREDIENT DIFLUBENZURON

When used as directed, Heifermaker w/Clarify® will provide sufficient diflubenzuron larvicide to prevent the emergence of adult house, stable, horn, and face flies from the manure of treated cattle. Existing adult flies will not be affected. **Use when feed is formulated for animals 201 lbs. and over:** Feeding rate will supply diflubenzuron at a level of 0.1mg per kg body weight per day. Feeding rate will supply a sufficient level of diflubenzuron to control listed flies when fed on a daily basis. Provide good quality forage and clean drinking water at all times.

CAUTION

Bentonite should not be used in decoquinatate feeds. DO NOT FEED TO SHEEP DUE TO HIGH LEVELS OF SUPPLEMENTAL COPPER. Store in a dry, well-ventilated area protected from rodents and insects.
